

ANATOLÍA TANI VE BİYOTEKNOLOJİ ÜRÜNLERİ AR-GE SAN. VE TİC. A.Ş. WITHIN THE SCOPE OF THE LAW NO. 6698 ON THE PROTECTION OF PERSONAL DATA DATA SUBJECT APPLICATION FORM

Anatolia Tanı ve Biyoteknoloji Ürünleri Ar-Ge San. ve Tic. A.Ş. (hereinafter referred to as the "**Company**"), personal data owners (hereinafter referred to as the "**Applicant**"), who are defined as "data subjects" in the Personal Data Protection Law No. 6698 (hereinafter referred to as the "**KVKK**"), are granted the following rights under Article 11 of the KVKK:

- · Learning whether your personal data is processed,
- · Requesting information if your personal data has been processed,
- · Learning the purpose of processing your personal data and whether they are used appropriately,
- · Knowing the third parties to whom your personal data is transferred at home or abroad,
- In case your personal data is incomplete or incorrectly processed, requesting that it be corrected and requesting that the transaction carried out within this scope be notified to third parties to whom your personal data has been transferred.
- Requesting the deletion or elimination of your personal data and notifying the third parties to whom the
 personal data has been transferred, if the reasons requiring processing are no longer valid, although it has
 been processed in accordance with the provisions of other laws and other legislation related to KVKK,
- Objecting to the occurrence of a result against you by analysing the processed data exclusively through automated systems,
- Requesting compensation in case you suffer due to unlawful processing of your personal data.

Pursuant to paragraph 1 of Article 13 of the KVKK and the "Communique on the Procedures and Principles of Application to the Data Controller", applications to be made to our Company regarding these rights must be submitted in writing or by sending an e-mail to kvkk@anatoliageneworks.com by using the e-mail address previously notified to our Company by you and registered in our Company's system or by other methods to be determined by the Personal Data Protection Board (hereinafter referred to as the "Board") in the future.

Within this framework, the applications to be made to our Company in "written" form, will be available to delivery,

- By applying to the Company personally by the Applicant,
- · By notary or by registered and reply to paid letter,
- By sending an e-mail to our Company's kvkk@anatoliageneworks.com address, in case the Applicant has an e-mail address they can use which is registered in the Company's systems,

with the printout of this form.
