1. DATA CONTROLLER

We collect name-surname, name of firm, identity/tax numbers, contact information and invoice details.

Your personal data be collected via unautomated methods in verbal, writing or electronic environment for purposes defined (2) topic in this Notice and legal basis mentioned below:

For complying to the financial legislation	Processing is necessary for compliance with a legal obligation to which the controller is subject
For managing social media For sending bulletins	The data subject has given consent to the processing of his or her personal data for one or more specific purposes

6. RETENTION PERIOD

Data retention period depends on the processing purposes. However, the maximum retention period of personal data which is subject of this Notice is 10 years in context of legal necessities.

7. YOUR RIGHTS ON YOUR PERSONAL DATA

The Company would like to make sure you are fully aware of all your data protection rights. Every data subject is entitled to the following:

- The right to access You have the right to request the Company for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification You has the right to request that the Company correct any information you believe is inaccurate. You also have the right to request the Company to complete the information you believe is incomplete.
- The right to erasure You has the right to request that the Company erase your personal data, under certain conditions.
- The right to restrict processing You have the right to request that the Company restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to the Company's processing of your personal data, under certain conditions.
